

### 2022 CANADIAN TAXABLE INCOME CALCULATION

The table below provides the Canadian taxable income information for the regular LP unitholders of Brookfield Infrastructure Partners for its 2022 taxation year. All amounts are reported in Canadian dollars (unless stated otherwise) and are on a per unit basis by quarter.

Taxable income is allocated to unitholders based upon distributions received during the year.
